**AN ORDINANCE OF THE CITY OF GROESBECK, TEXAS, ADOPTING A JUVENILE CURFEW; PROVIDING FOR PROCEDURES AND REGULATIONS REGARDING LAWFUL HOURS; PROVIDING FOR ENFORCEMENT ACTION; ESTABLISHING REPORTING REQUIREMENTS; PROVIDING FOR PENALTIES; AND PROVIDING AN EFFECTIVE DATE**
