A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GROESBECK, TEXAS AUTHORIZING THE DISBURSEMENT OF MONIES FROM THE CITY'S CORONAVIRUS RELIEF FUND ('CRF') ALLOCATION IN SUPPORT OF THE ACQUISITION OF DISTANCE LEARNING INFORMATION TECHNOLOGY EQUIPMENT FOR THE GROESBECK INDEPENDENT SCHOOL DISTRICT ('GISD')

WHEREAS, the City has previously accepted receipt of an allocation from the CRF and further that such federal monies were provided to the City to offset qualifying expenses of the City, and expenses of supporting stakeholders, pursuant to implementation of Coronavirus mitigating strategies.

WHEREAS, the City finds it in the best interest of the citizens of Groesbeck, and those students who are supported by the GISD, to disburse monies from the City's Coronavirus Relief Fund allocation in support of the GISD; and

WHEREAS, the City is satisfied the GISD has exercised due diligence in the acquisition of certain Information Technology equipment, including internet reception devices ('hotspots'), for the direct use of GISD students, to enable an off-campus learning environment which is part of the GISD's Coronavirus mitigation strategy; and

WHEREAS, the City's authorized disbursement of funds represents a portion of the total acquisition cost of the aforementioned Information Technology equipment and the City has received adequate assurances that the full cost of acquisition of the aforesaid equipment has previously been secured by the GISD; and

WHEREAS, The City of Groesbeck designates City Administrator Chris Henson as the City's authorized official who is hereby authorized to administer the funds allotted for disbursement as described herein;

NOW THEREFORE, BE IT RESOLVED that the City of Groesbeck approves the disbursement of \$26,125.00, from the City's CRF allocation, in support of the acquisition described herein, as part of the City's and the GISD's Coronavirus mitigation effort.
