## 12. Consider Approval of Resolution No. 20-R-02, Water Line Reimbursement Agreement

Mayor O'Docharty presented Resolution No. 20-R-02, Water Line Reimbursement Agreement to the council for approval.

### **RESOLUTION NO. 20-R-02**

WHEREAS, water lines were installed and paid for by one landowner, Randy Sims, in order to serve property owned by him; and

WHEREAS, it has been determined by the City Council of the City of Groesbeck that this landowner is entitled to a fair share reimbursement for expenses incurred in building said water lines; and

WHEREAS, development in the area may cause the need for additional taps to said water lines to further the growth and development of the community; and

WHEREAS, it is the intent of the City Council of the City of Groesbeck to provide service as adequate after additional taps are made as that being provided at present and that service will not be decreased in any way and that the present pressure reading on said water line is 40 - 60 PSI; and

WHEREAS, it has been deemed necessary by the City Council of the City of Groesbeck to determine an amount for the fair share reimbursement to said landowner for expenses in building the water lines; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GROESBECK, TEXAS, that said landowner is entitled to a fair share reimbursement for expenses on installing a water line extending from the City mains to their properties located on FM 2489 and that due to additional growth and development in the area, additional taps to the water lines will be permitted by the City of Groesbeck and that the City shall provide service as adequate in the future as is being provided at present, that being 40 - 60 PSI as tested on January 16, 2020, by City personnel and that the City may allow any number of taps desired on the 6 inch line on FM 2489 and that the City may allow a total of 24 taps on the (6) inch water line, one being that of Randy Sims, and that the City shall collect the reimbursement from those residents tapping the lines and same shall be reimbursed to the said landowner within thirty (30) days after received by the City. The amount to be collected for the new taps to the line by the City and reimbursed to said landowner for the water line taps is \$4,791.66 for each tap and normal and customary fees charged by the City for making a water tap and bore (if necessary) will be in addition to the tap charges for reimbursement purposes and such charges and fees will be the fees in effect at the time said tap is made. The reimbursement to landowner for taps shall expire in five (5) years from the date of this Resolution on January 21, 2020 and shall not exceed \$115,000.00 to qualified landowner.

## 14. Consider Approval of Resolution No. 20-R-03, Sewer Line Reimbursement Agreement

Mayor O'Docharty presented Resolution No. 20-R-03, Sewer Line Reimbursement Agreement to the council for approval.

#### **RESOLUTION NO. 20-R-03**

WHEREAS, sewer lines were installed and paid for by one landowner, Randy Sims, in order to serve property owned by him; and

WHEREAS, it has been determined by the City Council of the City of Groesbeck that this landowner is entitled to a fair share reimbursement for expenses incurred in building said sewer lines; and

WHEREAS, development in the area may cause the need for additional taps to said sewer lines to further the growth and development of the community; and

WHEREAS, it is the intent of the City Council of the City of Groesbeck to provide service as adequate after additional taps are made as that being provided at present and that service will not be decreased in any way, and

WHEREAS, it has been deemed necessary by the City Council of the City of Groesbeck to determine an amount for the fair share reimbursement to said landowner for expenses in building the sewer lines; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GROESBECK, TEXAS, that said landowner is entitled to a fair share reimbursement for expenses on installing a sewer line extending from the City mains to their properties located on FM 2489 and that due to additional growth and development in the area, additional taps to the sewer lines will be permitted by the City of Groesbeck and that the City shall provide service as adequate in the future as is being provided at present, and that the City may allow any number of taps desired on the four (4) inch line on FM 2489 and that the City may allow a total of six (6) taps on the (4) inch sewer line, one being that of Randy Sims, and that the City shall collect the reimbursement from those residents tapping the lines and same shall be reimbursed to the said landowner within thirty (30) days after received by the City. The amount to be collected for the new taps to the line by the City and reimbursed to said landowner for the sewer line taps is \$7,500.00 for each tap and normal and customary fees charged by the City for making a sewer tap

and bore (if necessary) will be in addition to the tap charges for reimbursement purposes and such charges and fees will be the fees in effect at the time said tap is made. The reimbursement to landowner for taps shall expire in five (5) years from the date of this Resolution on January 21, 2020 and shall not exceed \$45,000.00 to qualified landowner.
