SECTION 1 The City of Groesbeck City Officers' Election will be held on May 1, 2021 for the purpose of electing two (2) Aldermen (Council Members).

SECTION 2 Early voting by personal appearance will be conducted each weekday at the Groesbeck Convention Center, 106 East Navasota Street, City of Groesbeck, Texas, between the hours of 8:00 a.m. and 5:00 p.m. on Monday through Friday, April 19, 20, 21, 22, 23; and between 7:00 a.m. and 7:00 p.m. on Monday and Tuesday, April 26 and 27, 2021.

SECTION 3 Applications for ballot by mail shall be mailed to:

The first day to accept an application for a mail ballot is March 3, 2021. The first day to mail an early voting ballot is March 17, 2021. The Early Voting clerk must receive applications for ballots by mail no later than the close of business on April 16, 2021.
