ORDINANCE NO. 22-O-04

AN ORDINANCE ADOPTING AN AMENDED CITY OF GROESBECK INVESTMENT POLICY.

WHEREAS, the Legislature of the State of Texas enacted House Bill 2459 amending the Public Funds Investment Act; and

WHEREAS, the Public Funds Investment Act, as amended, requires the city to adopt an investment policy by rule, order, ordinance or resolution; and

WHEREAS, the attached investment policy complies with the Public Funds Investment Act, as amended, and authorizes the investment of City funds in safe and prudent investments; and

WHEREAS, the Public Funds Investment Act, as amended, requires the City to designate by rule, order, ordinance or resolution, one or more officers or employees of the City as investment officers to be responsible for the investment of its funds:

WHEREAS, the City is required to review the City's investment policy annually; and

WHEREAS, this review is authorized by the Public Funds Investment Act, as amended.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Groesbeck, Texas:

That the City of Groesbeck Investment Policy, as amended, attached hereto as "Exhibit A" is hereby adopted as the investment policy of the City of Groesbeck effective December, 2022.

9. Consider Approval of Ordinance No. 22-O-05, Transfer of Property from City to EDC

Mayor Dawley presented Ordinance No. 22-O-05, Transfer of Property from City to EDC to the council for approval.

ORDINANCE NO. 22-O-05

CONSIDER AN ORDINANCE TRANSFERRING OWNERSHIP OF SPECIFIED PROPERTY FROM THE CITY OF GROESBECK TO THE GROESBECK ECONOMIC DEVELOPMENT CORPORATION FOR THE PURPOSE OF SUPPORTING BUSINESS GROWTH AND ECONOMIC DEVELOPMENT IN THE CITY OF GROESBECK PURSUANT TO SECTION 253.012 OF THE TEXAS LOCAL GOVERNMENT CODE, PROVIDING FOR A REVERSIONARY CLAUSE, AUTHORIZING THE CITY ADMINISTRATOR TO EXECUTE DOCUMENTS EFFECTUATING THE TRANSFER OF PROPERTY, PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Groesbeck "City" purchased the land located at 314 W. Navasota Street "Property", located in the corporate limits of the City of Groesbeck, Texas, more particularly described as follows:

BEING the West one-half (1/2) of Lot Eight (8), and all of Lot Seven (7), Block 103, City of Groesbeck, Texas, according to the map of record in Vol. 2, page 44, Plat Records of Limestone County, Texas, and being the same tract of land conveyed to the City of Groesbeck recorded in Document no. 2022-0003364, Official Public Records, Limestone County, Texas.

WHEREAS, supporting business growth and economic development including the development of new and expanded business enterprises that create or retain primary jobs is a public purpose of the municipality; and

WHEREAS, the Groesbeck Economic Development Corporation "EDC" is a Type B economic development corporation Chartered in 1997 by the Groesbeck Mayor and City Council to support business growth and economic development in the city of Groesbeck; and

WHEREAS, the City desires to transfer the Property to the EDC pursuant to Texas Local Government Code, Section 253.012 in consideration for the EDC's agreement to use the Property in a manner that primarily promotes a public purpose of the municipality; and

WHEREAS, the EDC has agreed to use the Property in a manner that primarily supports a public purpose; and

WHEREAS, the use of the Property by the EDC supports a public purpose of the City and is sufficient consideration for the transfer of the Property to the EDC; and

WHEREAS, the transfer of the Property from the City to the EDC is in the best interest of the City and citizens of Groesbeck, Texas.

WHEREAS, if at any time, the EDC fails to use the Property in a manner that promotes a public purpose of the municipality, ownership of the subject property shall automatically revert to the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GROESBECK, TEXAS AS FOLLOWS:

All of the above premises are hereby found to be true and correct legislative and factual findings of the Groesbeck City Council, and hereby approved and incorporated into the body of this Ordinance as if copied in their entirety.

The City Council hereby authorizes the sale, transfer, and conveyance of the subject Property to the Groesbeck Economic Development Corporation pursuant to Section 253.012 of the Texas Local Government Code.

The Groesbeck City Administrator is hereby authorized to take appropriate action to effectuate this transfer of the Property, including execution of the conveyance, from the City to the EDC.

A reversionary clause shall be incorporated into the deed stating that if at any time, the EDC fails to use the Property in a manner that promotes a public purpose of the municipality, ownership of the subject Property automatically reverts to the City.

This Ordinance shall be effective immediately upon passage and publication as provided by law.
