### **ORDINANCE NO. 24-O-03**

# AN ORDINANCE ADOPTING AN AMENDED CITY OF GROESBECK INVESTMENT POLICY.

**WHEREAS**, the Legislature of the State of Texas enacted House Bill 2459 amending the Public Funds Investment Act; and

**WHEREAS**, the Public Funds Investment Act, as amended, requires the city to adopt an investment policy by rule, order, ordinance or resolution; and

**WHEREAS**, the attached investment policy complies with the Public Funds Investment Act, as amended, and authorizes the investment of City funds in safe and prudent investments; and

**WHEREAS**, the Public Funds Investment Act, as amended, requires the City to designate by rule, order, ordinance or resolution, one or more officers or employees of the City as investment officers to be responsible for the investment of its funds:

WHEREAS, the City is required to review the City's investment policy annually; and

WHEREAS, this review is authorized by the Public Funds Investment Act, as amended.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Groesbeck, Texas:

That the City of Groesbeck Investment Policy, as amended, attached hereto as "Exhibit A" is hereby adopted as the investment policy of the City of Groesbeck effective December, 2024.

#### 9. Consider Approval of Flock Safety System

City Administrator Chris Henson shared the benefits of the flock safety system to the council. This would include placing up to eight perimeter cameras at each city entry/exit of the city, including Hwy. 14 north and South, Hwy 164 East and West and Navasota-East/South FM 937. The annual cost for the system setup will be approximately \$26,000.00 requiring a two-year contract. If approved by the council, he plans to apply for a grant that would cover 80% of the cost for next year and use police department's forfeiture, donation and contingencies funds for this year.

#### **RESOLUTION No. 24-R-08**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GROESBECK, TEXAS, AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO A MULTIPLE-USE AGREEMENT WITH THE TEXAS DEPARTMENT OF TRANSPORTATION ALLOWING THE INSTALLATION AND OPERATION OF AUTHOMATED LICENSE PLATE RECOGNITION CAMERAS IN TEXAS DEPARTMENT OF TRANSPORTATION RIGHT-OF-WAY; AND PROVIDING AN EFFECTIVE DATE

**WHEREAS**, the City Council of the City of Groesbeck has determined the addition of Automatic License Plate Recognition (ALPR) Cameras will increase public safety and aid the Police Department in its crime prevention efforts and strategies; and

**WHEREAS**, the City Council desires to engage with the Texas Department of Transportation (TxDOT) and asks that flock safety be allowed to place ALPR Cameras in TxDOT right-of-way on behalf of the City of Groesbeck; and

**WHEREAS**, the City Council finds it to be in the public interest to authorized the City Administrator to sign a Multiple-Use Agreement with TxDOT.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GROESBECK, TEXAS, THAT:

#### **SECTION 1.**

The City Council hereby authorizes the City Administrator to enter into a Multiple-Use Agreement with TxDOT for the installation and operation of ALPR Cameras in TxDOT right-of-way.

#### **SECTION 2.**

This resolution shall take effect immediately upon adoption.
