NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GROESBECK, TEXAS, that the Mayor and City Secretary be authorized to issue to the Farmers State Bank, Groesbeck, Texas, a City of Groesbeck Warrant in the principal amount of not more than \$184,608.44 said Warrant to bear simple interest at the beginning rate not to exceed seven & one-quarter percent per (6.5%) per annum for a period of twelve (12) months, to be due on or before the 18th day of July, 2026. An Annual payment of principal and interest based upon a fifteen (15) year amortization of the original loan amount will be due on or before the 18th day of July, 2026.
