STERILIZATION; PROVIDING FOR EXEMPTIONS TO SECTION 36; SETTING AN EFFECTIVE DATE FOR ANIMALS RUNNING AT LARGE; AND PROVIDING A PENALTY TO OWNER OR CUSTODIAN OF DOGS AND CATS UPON FAILURE TO COMPLY WITH ORDINANCE
